



- 4) That no part of the income from the Institution is being and will be diverted to any individual in the Trust/Society/Company/School Management Committee or to any other person/entity. The saving, if any, after meeting the recurring and non-recurring expenditure and contributions to developmental, depreciation, and contingency funds, will be further utilized for promoting the school and extending the cause of education in the same school only.
- That school is not paying any charges towards using the name, motto, logo, or any other non-academic activities to any other institution, organization, or body.
- 6) That the school will not open classes under CBSE pattern particularly class IX/X/XI/XII and will not use CBSE name in any manner without obtaining affiliation.
- 7) That the Principal and Correspondent/Manager of the school have individually gone through the provisions contained in the affiliation & examination bye-laws and the circulars issued by the Board from time to time. The school undertakes to abide by the provisions contained in the affiliation & examination bye-laws, directions issued from time to time, and the law of the land.
- 8) That the school will ensure compliance of all statutory requirements like EPF, ESI and Labor Laws etc. with respect to the school and staff of the school.
- 9) That the school will ensure that the Building Safety, Fire Safety, Water Safety, Health, and Hygiene certificates are being issued or renewed by the concerned municipal or state authorities from time to time as per the prescribed term.
- 10) That the school will ensure that all required infrastructure is available with the school before starting classes.
- 11) That the school will ensure that a sufficient number of qualified teachers as per the provisions contained in affiliation bye-laws are available with the school before starting classes.
- 12) That the school will follow the provisions related to fee contained in affiliation bye-laws and will disclose the details of the fee to the students/parents every year before the start of the session without resorting to any hidden charges in the heads of the fee.
